Sample Constituent Phone Call

[Staff]

Good afternoon, you have reached the office of [policymaker], how can I help you?

[Constituent]

Hello, my name is _____, and I'm a constituent of [policymaker]. I am calling in support of/opposition to [issue/bill #]. Does [policymaker] have a position on this issue?

- **[if policymaker has NO POSITION]**

[Issue/bill #] is important to the constituents of our district for several reasons. [Include no more than three one-sentence reasons to support or oppose the issue or policy.] I hope that [policymaker] will consider my opinion as one of [his/her] constituents and will decide to [support/oppose].
